CRIT respectfully submits the following corrections to the transcripts of the Evidentiary Hearings held on July 29 and 30, 2014 regarding the Palen Solar Electric Generating System:

- **Throughout both transcripts:** When used to describe the Mojave National Preserve, the Mojave desert, or the Fort Mojave Indian Tribe, “Mojave” is spelled correctly (correct spellings identified in 7/29/14 transcript at pages 4, 70:24, 265:5, 265:12, 269:16, 278:22, 278:25, 279:2; in 7/30/14 transcript at pages 5, 321:7, 321:16, 351:10, 354:13, 354:14, 354:23, 354:25, 356:20). However, all other references to “Mojave” are to the Mohave people of the Colorado River Indian Reservation and their culture, and should be spelled as “Mohave.”
- 7/29/14, Page 162:4: “Fred and Ernestine Sharpe”
- 7/29/14, Page 165:16: “Jose Sharp”
- 7/29/14, Page 165:18 through Page 166:9: this entire section should be marked as a quotation.
- 7/29/14, Page 165: 4: Chief **Irataba**”
- 7/29/14, Page 228:18: “Valerie ~~Welch~~**Welsh-Tahbo**”
- 7/29/14, Page 228:19: “**Council member** Johnson Fisher”
- 7/29/14, Page 232:17: “it’s about the **manos and matates**”
- 7/29/14, Page 242:16: “a botched ~~bluestone~~**Blue Stone** study
