## Notice of Workshop on Forms and Instructions to Collect Electricity Demand Forecast and Resource Plan Data from Load-Serving Entities

### Background

To develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety, the Energy Commission is directed by Public Resources Code Section 25301 to regularly assess all aspects of energy demand and supply. These assessments are the foundation for analysis and policy recommendations to the Governor, Legislature, and other agencies. To carry out these assessments, "the Commission may require submission of demand forecasts, resource plans, market assessments, and related outlooks from electric and

natural gas utilities, transportation fuel and technology suppliers, and other market participants.” (Public Resources Code Section 25301(a).)

Load-serving entities (LSEs) in California with annual peak demand greater than 200 megawatts are required to submit electricity demand forecast data and electricity supply resource plans through these forms. All publicly owned utilities in California are required to submit resource adequacy plans showing how year-ahead demand for energy and annual peak load will be met by supply resources.

This information will provide a foundation for the analyses and recommendations in the *2015 IEPR*, including resource assessment and analysis of progress towards energy efficiency, demand response and renewable energy goals. The data will also be used to develop Energy Commission forecasts, which are used in the California Public Utilities Commission procurement and resource adequacy proceedings, as well as in transmission planning studies conducted by the California Independent System Operator. This information will also provide the Energy Commission with a better understanding of LSE planning assumptions and supply resource commitments, allowing the Energy Commission to assess current conditions in electric generation system infrastructure needs and to identify major statewide trends affecting electricity supply and reliability.

## Public Comment

**Oral Comments.** Staff will accept oral comments during the workshop. Any comments will become part of the public record in this proceeding.

**Written Comments.** Written comments should be submitted by **November 14, 2014**.
