## NOTICE OF RECEIPT PETITION TO AMEND THE CALIFORNIA ENERGY COMMISSION DECISION FOR THE INLAND EMPIRE ENERGY CENTER (01-AFC-17C)

On October 7, 2014, Inland Empire Energy Center, LLC filed a petition with the California Energy Commission (Energy Commission) requesting to modify the Final Decision for Inland Empire Energy Center (IEEC). The combined-cycle, natural gasfired, 810-megawatt facility was certified by the Energy Commission in its Decision on December 17, 2003. Unit 1 began commercial operation in January of 2009 and Unit 2 in June, 2010. The facility is located in the City of Menifee, in Riverside County, California.

## DESCRIPTION OF PROPOSED MODIFICATION

The modification proposed in the petition would replace one of the IEEC's existing General Electric (GE) 7H-technology gas turbines (GE S107H) with a functionally identical GE 7HA.01 gas turbine, the latest generation in H technology.

Modifications also proposed in the petition would:

- Change Air Quality Conditions of Certification AQ-8, AQ-17, AQ-34, and AQ-SC16 to comply with South Coast Air Quality Management District's testing requirements for the GE 7HA.01;
- Delete AQ-SC17 because Energy Commission Air Quality Staff has stated it is no longer necessary<sup>1</sup>;
- Add new Condition of Certification AQ-SC18 for Energy Commission reporting compliance for the new turbine;
- Update NOISE-6 for field noise survey after the new turbine installation; and
- Update STRUC-1, STRUC-2, TRANS-1, and TRANS-2 for the new turbine installation.
