### **Background**

On December 27, 2013, AES Southland Development, LLC submitted an Application for Certification (AFC) to modernize the existing Alamitos Generating Station (AGS). The Alamitos Energy Center (AEC) would be located on approximately 63 acres of privately-owned land. The proposed project site is bounded on the north by State Route 22, on the east by the San Gabriel River, on the south by 2nd Street, and on the west by N. Studebaker Road in the City of Long Beach, Los Angeles County, California. The AEC is a proposed natural-gas-fired combined-cycle electrical generating facility with a net generating capacity of 1,936 megawatt (MW), which would replace and be constructed on the site of the AGS.

The AEC was deemed “data adequate” on March 12, 2014. On April 29, 2014, the Committee conducted a site visit and public Informational Hearing and Scoping Meeting in Long Beach, California. On May 6, 2014, the Committee issued the Committee Scheduling Order.

### **Purpose of the Status Conferences**

The Committee will conduct the status conferences to discuss the progress made in the proceeding, any barriers to the timely completion of Staff’s analysis, date-specific project milestones, and any other matters relevant to the schedule. They may also address any then-pending motions, petitions, and other requests that are ripe for consideration.

As allowed by California Code of Regulations, title 20, section 1208, the Status Conferences may be conducted by the Hearing Adviser without either Commissioner being present.

### **Closed Sessions**

The Committee may, pursuant to Government Code section 11126, temporarily adjourn to a closed session to deliberate on matters before the Committee for decision such as the preparation of its decisions or motions and other matters then pending before the Committee.

### **Notice of Possible Staff Workshop**

Energy Commission Staff (Staff) may discuss proposed changes to its analysis and recommendations, including proposed conditions of certification, with any other party only in a public meeting and only after providing notice. (Cal. Code Regs., tit. 20, §1710,

subd. (a).) In order to effectuate resolution of outstanding issues, the Committee may authorize Staff to conduct a Staff Workshop during or following the conclusion of the Status Conference. Such a workshop would be open to all parties and the public and be made remotely accessible to the same extent as is the Status Conference, except that the workshop would not be transcribed.

### **Public Adviser and Public Participation**

The Energy Commission invites members of the public and other interested parties to participate either on an informal basis or by intervening in the proceeding. Both types of participation allow written and oral comments. At the informal participation level, written and oral public comments are considered by the Commissioners and are part of the record, but are not part of the formal evidentiary record. Intervenors have the right to introduce evidence into the evidentiary record and cross-examine the other parties' witnesses.

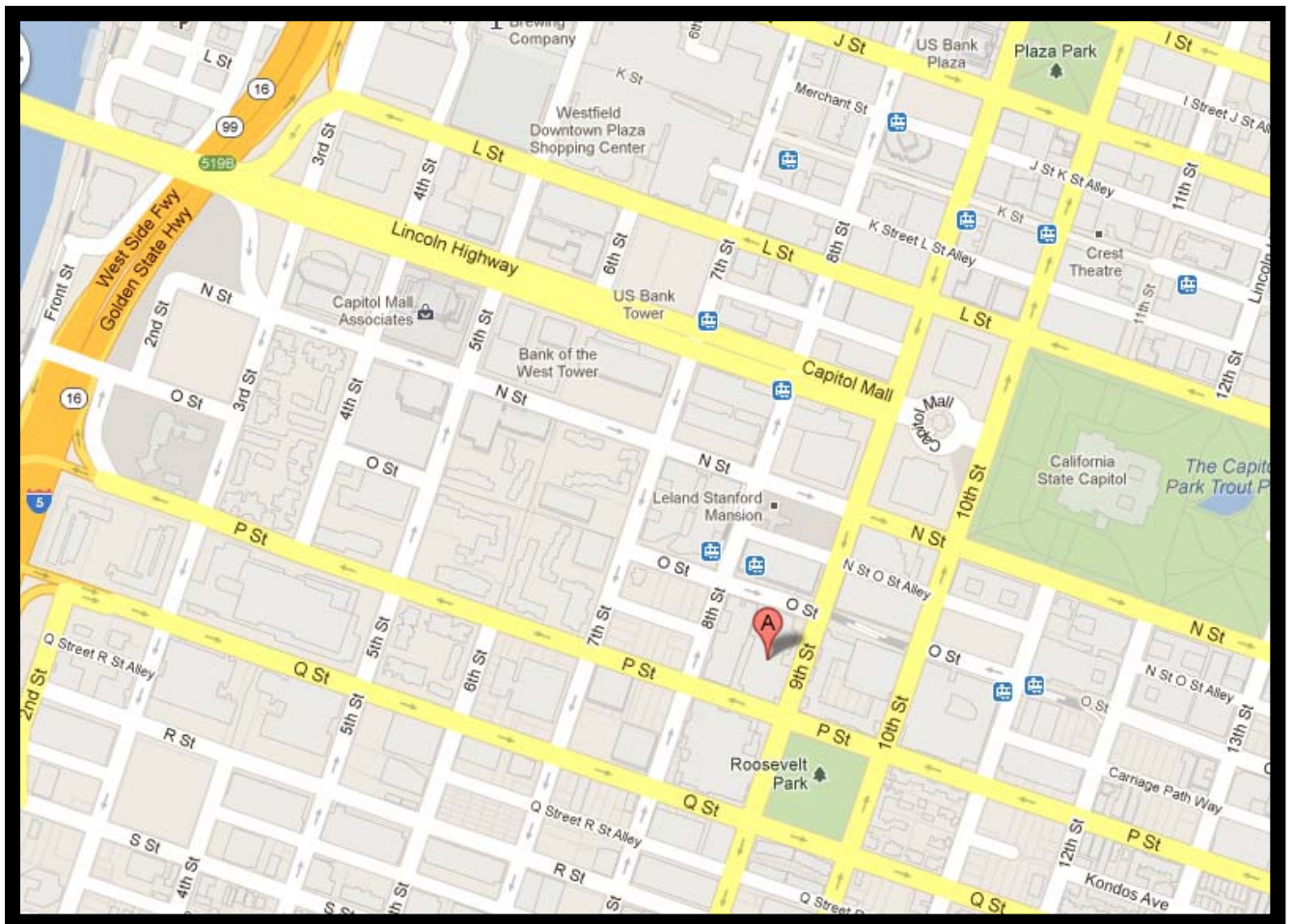
