Background

On February 2, 2005, the Energy Commission approved new generation units (i.e., new Units 5, 6, and 7) to replace existing El Segundo Generating Station (ESGS) Units 1 and 2, in the city of El Segundo, Los Angeles County. This decision was amended on June 30, 2010, with the Commission approving a change to dry cooling technology and natural-gas-fired, rapid-start, combined-cycle units with a total generating capacity of 560 MW. Units 1 and 2 were demolished during the construction process for the new units (i.e, now called El Segundo Energy Center Units 5, 6, 7, and 8) which began operating in August 2013.

On April 23, 2013, El Segundo Energy Center, LLC filed the current amendment petition which proposed demolition of old Units 3 and 4, and construction of new gas-fired Units 9, 10, 11, and 12 at the El Segundo Energy Center (ESEC). The proposed new units would have a replacement capacity of approximately 435 MW and use dry cooling technology. In addition to demolition of old units, the current amendment project would consist of a proposed gas-fired rapid-start combined cycle unit, a steam turbine generator unit, and two gas-fired simple-cycle units. The project will not require new off-site transmission lines or natural-gas pipelines.

Purpose of the Status Conferences

The Committee will conduct the status conferences to discuss the progress made in the proceeding, any barriers to the timely completion of Staff's analysis, date-specific project milestones, and any other matters relevant to the schedule. They may also address any then-pending motions, petitions, and other requests that are ripe for consideration.

As allowed by California Code of Regulations, title 20, section 1208, the status conferences may be conducted by the Hearing Adviser without either Commissioner being present.

Closed Sessions

The Committee may, pursuant to Government Code section 11126, temporarily adjourn to a closed session to deliberate on matters before the Committee for decision such as the preparation of its decisions or motions and other matters then pending before the Committee.

Order Changing Due Dates for Status Reports

All parties shall file status reports on the second Monday of each month beginning November 10, 2014, and continuing thereafter until further order from the Committee.

Notice of Possible Staff Workshop

Energy Commission Staff (Staff) may discuss proposed changes to its analysis and recommendations, including proposed conditions of certification, with any other party only in a public meeting and only after providing notice. (Cal. Code Regs., tit. 20, §1710, subd. (a).) In order to help resolve outstanding issues, the Committee may authorize Staff to conduct a Staff Workshop during or following the conclusion of the Status Conference. Such a workshop would be open to all parties and the public and be made remotely accessible to the same extent as is the Status Conference, except that the workshop would not be transcribed.

Public Adviser and Public Participation

The Energy Commission invites members of the public and other interested parties to participate either on an informal basis or by intervening in the proceedings. Both types of participation allow written and oral comments. At the informal participation level, written and oral public comments are considered by the Commissioners and are part of the record, but are not part of the formal evidentiary record. Intervenors have the right to introduce evidence into the evidentiary record and cross-examine the other parties' witnesses.


