Amended CECP Revised EPS Demolition Air Emission Calculations

In response to some clarification questions raised during the 9/24/14 CEC workshop for the Amended CECP regarding the Encina Power Station (EPS) demolition equipment engine ratings and demolition haul truck trips, the emissions associated with the demolition of the existing EPS have been revised. The revised emission estimates account for the following changes:

- Based on Section 2.1 of the 10/1/2014 EPS Demolition Plan, demolition activities are assumed to occur 6 days/week (the previous assumption was 5 days/week).
- Demolition equipment types¹:
 - The excavators are assumed to be either Cat. Model 349F (432 hp gross) or Cat. Model 336F (322 hp gross). The previous assumption was the use of excavators with the CalEEMod Model default engine rating of 162 hp.
 - The cranes are assumed to be Manitowoc Model 999 (400 hp gross). The previous assumption was the use of cranes with the CalEEMod Model default engine rating of 226 hp.
 - The rubber tire loaders are assumed to be Cat. Model 966K (296 hp gross). The previous assumption was the use of loaders with the CalEEMod Model default engine rating of 199 hp.
 - The track loaders are assumed to be Cat. Model 963D (189 hp gross). The previous assumption was the use of loaders with the CalEEMod Model default engine rating of 97 hp.
- The worker travel roundtrip distance was increased to 21.6 miles.² The previous assumption was the use of the CalEEMod Model default of 10.8 miles.
- The delivery truck travel roundtrip distance was increased to 14.6 miles. The previous assumption was the use of the CalEEMod Model default of 7.3 miles.
- The number of delivery truck trips was updated to include water demineralizer trailer deliveries (possibly required for operation of the new units).
- The haul truck travel roundtrip distance was increased to 62 miles.³ The previous assumption was the use of the CalEEMod Model default of 20 miles.
- The number of haul truck trips was updated to match the information in the 10/1/2014 EPS Demolition Plan.⁴
- All off-site truck haul trips were updated to account for a portion of unpaved road travel (each trip includes a round-trip distance of approximately 0.5 miles of unpaved road travel at a landfill or recycling center).

The updated EPS demolition emissions are summarized in the enclosed revised Tables 5.1F-12, 5.1F-15, 5.1F-16, 5.1F-17, 5.1F-18, 5.1F-19, and 5.1F-20.

¹ Based on discussions with a demolition subcontractor. As with the previous EPS Demolition emission calculations, the large demolition equipment (greater than 70 hp) are assumed to be equipped with EPA Tier 4i engines and the smaller equipment (70 hp and smaller) equipped with EPA Tier 4 engines.

² To reach additional towns in the project area.

³ This haul distance is sufficient to reach the county line (for hauling to facilities approved for hazardous waste), and sufficient to reach a majority of the demolition material recycling centers in the San Diego County, and sufficient to reach the Miramar Class III municipal solid waste landfill (for nonhazardous/nonrecyclable debris).

⁴ The number of truck trips calculated is based on tons of recyclable material, other debris, and hazardous waste (amounts of hazardous waste discussed in the Amended CECP, Section 5.14 Waste Management, Table 5.14-3), assuming an average load of 20 tons per truck.
