BACKGROUND

On October 27, 2014, the Energy Commission held a workshop to discuss a draft version of proposed changes to the Commission's regulations covering general process and procedure and siting. After reviewing comments made at the workshop and submitted during the comment period on the draft language staff has prepared this revised draft for additional public review.

DRAFT LANGUAGE
