Dear Mr. Ogelsby:

Kings River Conservation District has entered into a contract to sell the Malaga Power Plant (previously known as the Kings River Conservation District Peaker Plant) to Malaga Power, LLC ("Malaga Power"), which is owned by one or more private equity funds sponsored by The Carlyle Group, L.P. Upon completion of the sale, Malaga Power will assume responsibility for all aspects of the facility's operation, including compliance with the Conditions of Exemption adopted by the Commission as Appendix B to the Commission's "Small Power Plant Exemption Decision" approved on May 4, 2004 in Docket No. 03-SPPE-02. Malaga Power understands the Conditions of Exemption and, as of the closing date, agrees to comply with these conditions.

It is our understanding that, since the Malaga Power Plant was approved by the Commission pursuant to its Small Power Plant Exemptions process, the transfer of ownership provisions in California Code of Regulations, Title 20, Section 1769(b) do not apply. Nevertheless, we respectfully request that the Commission issue a letter acknowledging that, as of the closing date, the Conditions of Exemption will apply to Malaga Power, as the new owner. We will provide prompt notice to the Commission of the closing date.
