#### **Background**

The CECP was approved by the Energy Commission on May 31, 2012, as a 540-megawatt (MW) natural-gas combined-cycle power generator. It would consist of two power blocks, each having one rapid-response combustion turbine generator (CTG), one heat recovery steam generator (HRSG), one condensing steam turbine generator (STG), an air-cooled fin-fan cooler, and associated support equipment.

Two amendment petitions are being considered together in this proceeding. The first (Petition to Remove Obsolete Facilities to Support Construction of the Carlsbad Energy Center Project, TN 202267), seeks permission to demolish three above-ground storage tanks - tanks 1 and 2 to the west of the rail corridor, and tank 4 to the south of the approved project boundary. Those tanks would be demolished in addition to tanks 5-7 on the approved project site; tanks 5-7 were approved for demolition in the 2012 Commission Decision. The second petition (Petition to Amend Carlsbad Energy Center Project, TNs 202287-1, 202287-2, and 202287-3) would change the project to consist of six simple-cycle turbine generators producing approximately 632 MW. The project site would be expanded to include the storage tank (tank 4) area to the south of the presently approved area, adding seven acres to the approved 23 acre facility. A new administration and control building and a warehouse would be added on the site.

### **Purpose of Prehearing Conference**

The Prehearing Conference is a public forum where the Committee will assess the parties' readiness for an evidentiary hearing, identify areas of agreement or dispute, and discuss the remaining schedule and procedures necessary to conclude the amendment process. (Cal. Code Regs., tit. 20, § 1718.5.)

Local, state, federal, and tribal governmental agencies may participate at the Prehearing Conference and evidentiary hearings, as necessary. (Cal. Code Regs., tit. 20, § 1714.5.) Elected officials and members of the public may present public comments at these events and/or submit written comments via the Energy Commission's e-Commenting system at:

https://efiling.energy.ca.gov/Ecomment/Ecomment.aspx?docketnumber=07-AFC-06C.

All parties are **ORDERED** to file a Prehearing Conference Statement and Exhibit List no later than **3:00 p.m. on March 13, 2015**, unless otherwise directed by the Committee.

The **Prehearing Conference Statements** must specify under separate headings:

1. the issues about which there is disagreement among the parties and about which the party desires to present evidence or question other testimony. Simply saying that one wants to present testimony on a topic (or "all" topics) without further explanation or justification is insufficient; in most cases it will be necessary to narrow the description to at least a subtopic (for example "ammonia slip" in air quality). Failure to describe issues with sufficient specificity may result in the exclusion of testimony or questions;

- 2. the witnesses, including their qualifications, and evidence the party intends to introduce during the evidentiary hearings;
- 3. the names of any witnesses the party desires to have testify by telephone and justification for the request;
- 4. the witnesses of other parties whom they intend to question during the evidentiary hearings and the subject(s) of the questions;
- 5. topic by topic recommendations about whether the hearings be conducted via formal or the informal processes described below;
- 6. issues that may require legal argument or briefing, whether before or after the evidentiary hearings;
- 7. whether it would be productive to have oral argument at the beginning and/or close of the evidentiary hearings;
- 8. time estimates broken down by topic area and type (party's direct and rebuttal testimony, questioning of other party's witnesses, and oral argument); and
- 9. a list of any documents of which the party requests the Committee take official notice beyond those described below.

All documentary evidence must be docketed (filed) in this proceeding's docket<sup>3</sup> and have a transaction number (TN number) assigned by the California Energy Commission Dockets Unit in accordance with the General Orders Regarding Electronic Document Formats, Electronic Filing and Service of Documents and Other Matters filed June 20, 2014 (TN 202478). Exhibits without a TN will not be received into evidence absent a showing of good cause.

The **Exhibit Lists** shall be formatted as two columns. The first column shall list the proposed Exhibit Number. The second column shall contain the TN of the corresponding (exhibit) document. Hearing Office staff will then add the Exhibit Number information to the e-filing system.

Petitioner's exhibits shall be numbered *consecutively* as **Exhibits 1000 through 1999**; Staff's exhibits shall be numbered *consecutively* as **Exhibits 2000 through 2999**; Intervenor Terramar Association's exhibits shall be numbered *consecutively* as **Exhibits 3000 through 3999**; Intervenor Power of Vision's exhibits shall be numbered *consecutively* as **Exhibits 4000 through 4999**; Intervenor Rob Simpson's exhibits shall be numbered *consecutively* as **Exhibits 5000 through 5999**; Intervenor Robert Sarvey's exhibits shall be numbered *consecutively* as **Exhibits 6000 through 6999**.

Failure of a party to comply with the filing requirements stated in this Notice may preclude that party from participating in the evidentiary hearing.

#### **Committee's Intention to Consider the Use of Informal Hearing Procedures**

Pursuant to California Government Code section 11445.10 et seq., and Commission's regulations (Cal. Code Regs., tit. 20, § 1217), the Committee may conduct all or portions of the evidentiary hearing using an informal procedure. The informal hearing process will generally proceed in the following order:

- 1. All parties' experts on the topic at hand are sworn in as a panel.
- 2. Petitioner's experts would provide a brief opening statement summarizing the key points and conclusions of their testimony.
- 3. Staff's experts would provide a brief opening statement summarizing the key points and conclusions of their testimony.
- 4. Intervenors' experts would provide a brief opening statement summarizing the key points and conclusions of their testimony.
- 5. Open discussion between the expert panelists led by the Committee.
- 6. Attorneys may follow up with questions of their own or other expert witnesses to the extent the Committee finds the questioning productive.
- 7. At the conclusion of the attorney's examination of the experts, the Committee may ask witnesses additional questions or allow panelists to ask additional questions of each other and to offer follow-up answers.

In contrast a formal procedure would involve:

- 1. A party asks direct questions of its witnesses on the topic at hand, either one at a time or seated as a panel.
- 2. The other parties then, in turn, ask cross-examination questions of the witness or panel who just testified.
- 3. The offering party can ask re-direct questions.
- 4. The other parties can ask re-cross questions.
- 5. Repeat the above steps for the witnesses offered by the other parties.


