Dear Commissioners Douglas and Scott:

On August 20, 2014, AES Southland Development, LLC (the "Applicant") requested that the Committee suspend the processing of the Application for Certification for the Redondo Beach Energy Project (12-AFC-03; the "Application"), pending an election in Redondo Beach on the Harbor Village Plan Initiative. On September 2, 2014 the Committee issued an order suspending the proceeding until April 1, 2015.

The request for suspension stated that depending on the results of the election, the Applicant would either request that the Application be withdrawn or that the Commission continue processing the Application. In the election on March 4, 2015, the Initiative was not approved. Therefore, by this letter, the Applicant requests that the Commission resume processing of the Application.

A proposed schedule for resumption of the proceeding is attached. The proposed schedule is consistent with the Commission's typical timetable for processing of applications.

Prior to the suspension of the proceeding, Staff issued a Preliminary Staff Assessment ("PSA") for the Redondo Beach Energy Project. We are not aware of any changes in conditions or circumstances that would necessitate a supplement to the Application or require an update to the PSA. We recommend that the proceeding resume with a new 30-day public comment period on the PSA, commencing on April 1, 2015. We recommend that a PSA Workshop be conducted during the comment period.
