Dear Mr. Oglesby:

Because SDG&E experienced an unexpected delay in obtaining information needed to carry out its analyses on special energy and peak forecast adjustments such as, EV, PV, and DG which are needed to complete its deliverable, SDG&E respectfully requests an **eleven-day (11)** extension of the due date for submitting its Demand Forecast forms for the 2015 IEPR from April 13, 2015 to April 24, 2015.

In addition, SDG&E respectfully requests an eleven-day (11) extension of the due date for submitting its Supply Forecast forms for the 2015 IEPR from April 24, 2015 to May 4, 2015, so that we can incorporate the load forecast in that submittal.

SDG&E intends to continue to work diligently in completing the forecast. We believe the extra time will enable us to produce a high quality forecast, without needing to revise or update its submission, and doing so will not adversely affect the overall 2015 IEPR schedule.
