PLEASE TAKE NOTICE that the Energy Commission Committee assigned to conduct proceedings on the Application for Certification (AFC) for the Hydrogen Energy California Project (HECA) has scheduled a public Status Conference to review the progress of the case and consider Intervenors' Motion to Terminate the Application for Certification:

Background

On July 31, 2008, Hydrogen Energy International, LLC (Applicant) filed an Application for Certification (AFC) seeking authority to construct and operate the Hydrogen Energy California Project (HECA), an Integrated Gasification Combined Cycle (IGCC) power generating facility rated at a nominal gross generating capacity of 390 megawatts (MW). To avoid conflict with habitat for endangered species in the original location for the project, Applicant retracted the original AFC and filed a revised application on May 28, 2009, for the same project to be built at a different location. The proposed HECA would be located near the unincorporated community of Tupman in western Kern County, California, seven miles west of the city limit of Bakersfield.

The project would be fueled by a combination of coal and petroleum coke, and would inject its emissions of carbon dioxide (CO₂) into the adjacent Elk Hills Oil Field, operated by a unit of Occidental Petroleum, for carbon sequestration and enhanced oil recovery.

SCS Energy California, LLC acquired 100 percent ownership of HECA, LLC in September 2011, undertook the re-design of some aspects of the project, and submitted an Amended AFC in May 2012. An Informational Hearing and Site Visit and U.S. Department of Energy Scoping Meeting were conducted on July 12, 2012.

On June 28, 2013, Energy Commission Staff published the Preliminary Staff Assessment and Draft Environmental Impact Statement (PSA/DEIS). The Committee held a conference on November 20, 2013, to provide a public forum for discussion of the PSA/DEIS. The Committee issued a Revised Scheduling Order for the project on January 27, 2014, which called for publication of the Final Staff Assessment/Revised Draft Environmental Impact Statement (FSA/Revised DEIS) on March 31, 2014.

According to status reports issued by the parties since then, publication of the FSA/Revised DEIS has been delayed because Applicant has not provided information required by Staff to complete its analysis. Among outstanding items were responses to data requests regarding potential impacts in the Elk Hills Oil Field and specific, detailed information related to the carbon sequestration plan. According to Staff's April 7, 2014 Status Report, Occidental's Board of Directors had authorized Occidental California to become a separately traded company that would announce its management team in the third quarter 2014, which could impact the project schedule. Applicant was engaged in discussions with Occidental of Elk Hills regarding its continued participation in the project.

On March 3, 2015, Intervenors filed a motion, pursuant to Title 20, Section 1720.2, to terminate the AFC based upon an alleged lack of diligence on the part of Applicant to pursue completion of the review process. Applicant's response to the motion, dated March 18, 2015, sets forth factual assertions that Applicant is no longer certain the project will have the Elk Hills Oil Field as its carbon sequestration site. Applicant is focusing on alternative plans for use and/or storage of CO_2 , including discussions with un-named potential off-takers for the CO_2 .

In light of the lengthy deviation from the Scheduling Order's March 31, 2014 date for publication of the FSA/Revised DEIS and to address Intervenors' motion, the Committee has scheduled this Status Conference. Topics to be discussed are set forth in the Agenda included with this Notice.

Purpose of the Status Conference

The Committee will conduct the Status Conference to discuss the progress made in the proceeding, any barriers to the timely completion of Staff's analysis, date-specific

project milestones, and any other matters relevant to the schedule. It will also address Intervenors' Motion to Terminate and any other then-pending motions, petitions, and other requests that are ripe for consideration.

As allowed by California Code of Regulations, title 20, section 1208, the Status Conference may be conducted by the Hearing Adviser without either Commissioner being present.

Closed Session

The Committee may temporarily adjourn into closed session to deliberate pursuant to Government Code section 11126.


