- 3 HEARING OFFICER KRAMER: Okay, this is Paul
- 4 Kramer, the Hearing Advisor for the Carlsbad
- 5 Amendments Committee.
- In the room here at Hearing Room A, the
- 7 Rosenfeld Hearing Room at the Energy Commission, we
- 8 have our Presiding Member, Commissioner Karen
- 9 Douglas, Eileen Allen who is the Commissioners'
- 10 Technical Advisor on Siting Matters, our Hearing
- 11 Reporter, Jennifer Nelson, Commissioner Douglas's
- 12 Advisor, John Hilliard from the Staff, Shawn Pittard
- 13 for the Public Advisor's Office, and Susan Cochran
- 14 who has been helping me with the WebEx and audio
- 15 visual issues.
- I see we have a couple people on the
- 17 telephone, one is Jonathan Kendrick. Did you want to
- 18 identify yourself or say anything, sir?
- 19 MR. KENDRICK: Yeah, good morning. This is
- 20 Jonathan Kendrick with Locke, Lord, counsel for the
- 21 project owner, Carlsbad Energy Center, LLC.
- 22 HEARING OFFICER KRAMER: Okay, thank you.
- 23 Then we have one other person on the call, who is not
- 24 identified. If you want to identify yourself? I'm
- 25 not going to bother to go through our regular roster

- 1 of people because I can tell by looking who is there.
- 2 So the other person who is on the phone, if you want
- 3 to identify yourself -- you don't have to, but please
- 4 go ahead.
- 5 MR. THOMPSON: No, no, that's all right, I'm
- 6 not bashful, Paul. This is Allan Thompson.
- 7 HEARING OFFICER KRAMER: Hi, Allan. Okay,
- 8 the first order of business is to conduct hearings on
- 9 any pending motions. We really don't have anything
- 10 to talk about today, though, because one motion that
- 11 is pending, but was argued at the evidentiary
- 12 hearings was Mr. Sarvey's motion to require that the
- 13 project pay an AFC level of fees, and the Committee
- 14 had taken that under submission already.
- 15 The other one was just filed this week and
- 16 that was Mr. Simpson's motion to require the Petition
- 17 to modify the existing Amendment Petition and delay
- 18 issuance of a Proposed Decision; it's simply too
- 19 early to do anything with that, we just got it this
- 20 week, it would be unfair to have the parties argue
- 21 it, so we're expected that the parties, should they
- 22 choose to respond to that, will respond to that in
- 23 the normal timeframe. And then we'll get around to
- 24 ruling on it after the expiration of that timeframe.
- I got an email request from Ms. Siekmann

- 1 yesterday, she realized that she forgot to identify
- 2 her opening -- it might have been her rebuttal
- 3 testimony. Anyway, it was TN 203851, she forgot to
- 4 identify that as an exhibit. So if I had more of the
- 5 parties on the line, I might think about trying to
- 6 resolve that, but since I just heard about it
- 7 yesterday and not enough people are here, we'll have
- 8 to resolve that at some later time. But I'll just
- 9 note that's a request that I received. And basically
- 10 it was her opening testimony, but it also included
- 11 her exhibit list and I think it's fair to say we'll
- 12 be asking the parties at some point in the future if
- 13 they have any objection to bringing that in as an
- 14 exhibit.
- 15 That then takes us to public comment and I
- 16 have to ask, but I don't see anybody on the list or
- 17 in the room, but would anybody wish to make a public
- 18 comment on this proceeding?
- 19 MR. THOMPSON: Paul, this is Allan. I'd
- 20 like to follow-up briefly on Kerry Siekmann's exhibit
- 21 number. Briefs are due I think next week on the 22nd
- 22 and 23rd, and I'd like to reference that. Will we
- 23 have a number before briefs are due?
- 24 HEARING OFFICER KRAMER: Okay, if you'd
- 25 like, I'll put a number on it and I'll just call it

- 1 identified for the time being, not necessarily
- 2 admitted, we'll resolve that later.
- 3 MR. THOMPSON: That would be great.
- 4 HEARING OFFICER KRAMER: Okay. Anybody else
- 5 want to make a public comment? Okay, hearing none,
- 6 the Committee is going to go in closed session
- 7 pursuant to Government Code Section 11126(c)(3) which
- 8 allows a State body, including a delegated committee
- 9 such as this to hold a closed session to deliberate
- 10 on a decision to be reached in a proceeding the State
- 11 body is required by law to conduct.
- I supposed there's a remote possibility we
- 13 might have something to announce at the end of this
- 14 closed session, so we're going to keep the Court
- 15 Reporter around, and in case we have more complicated
- 16 words than the usual no comment words to report at
- 17 the end of the closed session, we, I think because of
- 18 time constraints, we'll probably -- so we can't
- 19 predict exactly when we'll be back, but I think as a
- 20 practical matter, we have to finish by 11:30 because
- 21 of some scheduling issues. But we will leave the
- 22 WebEx line open -- oh, okay, then what we're going to
- 23 do is we're going to definitely set a time for you so

8	really don't think it would be productive for any of
9	the parties to come here, certainly not those who are
10	down in San Diego, because the purpose will largely
11	be, again, to hold a closed session.
