**Re: Closing Date - Transfer of Ownership and Compliance Responsibilities
Malaga Power Plant - Dockets 03-SPPE-02, 03-SPPE-2C**

Dear Mr. Ogelsby and Ms. Stora:

In our letter to you, dated January 30, 2015, we stated that the Kings River Conservation District had entered into a contract to sell the Malaga Power Plant (previously known as the Kings River Conservation District Peaker Plant) ("Facility") to Malaga Power, LLC ("Malaga Power"). We also stated that, upon completion of the sale, Malaga Power would assume responsibility for all aspects of the Facility's operation, including compliance with the Conditions of Exemption adopted by the Energy Commission as Appendix B to the Energy Commission's "Small Power Plant Exemption Decision" approved on May 4, 2004 in Docket No. 03-SPPE-02.

In your letter to us, dated March 10, 2015, you acknowledged that, upon closing, Malaga Power would assume responsibility for all aspects of the Facility's operation. You also stated that, while the Facility has been exempted from the jurisdiction of the Energy Commission, your staff would note the change in ownership and operational control, upon closing.

The purpose of this letter is to provide notice that closing for the Facility occurred yesterday, April 15, 2015. As such, as of April 15, 2015, Malaga Power acquired the Facility and assumed responsibility for all aspects of the Facility's operation, including compliance with the Conditions of Exemption. Accordingly, we ask that you note the change in ownership and operational control.
