Proposed Amendments to Title 20 Commission Process and Procedure Regulations

The Notice of Proposed Action¹ issued on April 20, 2015, set a date of June 10, 2015, for consideration and possible adoption by the commission of the proposed amendments to Title 20 of the California Code of Regulations relating to the commission's process and procedures. The commission will <u>not</u> consider adoption of these matters on June 10, 2015, and the hearing date for consideration and possible adoption of the proposed amendments has been postponed to July 8, 2015. This will allow additional time for those interested to review and comment on the proposed language changes.

The comment period will also be extended. The public comment period will not close on June 8, 2015 as originally intended; instead, **the public comment period will close at 4 p.m. on June 23, 2015.**

This postponement is authorized by Section 11346.8(b) of the California Government Code.
