Dear Ms. Rasberry:

This letter is in response to your March 25, 2015, written request to extend the filing deadlines for certain *2015 Integrated Energy Policy Report (2015 IEPR)* electricity supply and demand forecast data due to an unexpected delay in obtaining information needed to carry out analyses on special energy and peak forecast adjustments, which are needed to complete these forms.

San Diego Gas & Electric (SDG&E) is seeking an 11-day extension from April 13, 2015, to April 24, 2015, to submit Demand Forecast Forms 1 through 6 and Form 8.2 to the Energy Commission.

SDG&E is also requesting an 11-day extension from April 24, 2015, to May 4, 2015, to submit Supply Forecast Forms S-1, S-2, and S-3 to the Energy Commission. (The eleventh day after April 24 is actually May 5, 2015.)


In addition, SDG&E is requesting an 11-day extension from June 1, 2015, to June 12, 2015, to submit Demand Forecast Forms 8.1a and 8.1b to the Energy Commission.

According to forms and instructions adopted by the Energy Commission on December 10, 2014, this information is to be submitted for our assessment work as part of the *2015 IEPR*.
