ACE was a 100-megawatt (MW) coal-fired circulating fluidized bed (CFB) cogeneration project, located on the northwest side of Searles Lake in Trona, San Bernardino County, California.


Modification Description:

Petition submitted by ACE Cogeneration Company, LP, to decommission the ACE project. New Conditions of Certification **AQ-SC4, AQ-SC5, AQ-SC6, HAZ-1, HAZ-2, HAZ-3, HAZ-4, WASTE-11, WORKER SAFETY-1, WORKER SAFETY-2, WORKER SAFETY-3**, and revisions to existing conditions of certification **CUL-2** and **CUL-3**, will assure compliance with LORS and reduce potential environmental impacts to a less than significant level.

On June 10, 2015, the California Energy Commission approved the above-described project decommissioning pursuant to a regulatory program certified by the California Secretary of Resources under section 21080.5 of the California Public Resources Code, finding that:

1. The project will not have a significant effect on the environment;
2. Mitigation measures were made a condition of approval of the project;
3. The project is in compliance with all laws, ordinances, regulations, and standards; and
4. A statement of Overriding Considerations was not adopted for the project.
