Dear Commissioners Douglas and Scott:

On May 7, 2015, the Committee for the RBEP Application for Certification issued a Revised Committee Scheduling Order. The Order indicated that the parties shall file status reports on or before the first of each month, commencing June 1, 2015, no later than 3:00 p.m. on the due date. Status reports shall inform the Committee whether or not case development is progressing satisfactorily and bring potential schedule delays and other relevant matters to the Committee's attention. The Committee further requested that the SCAQMD file status reports in the event that the timing of completion of its tasks fall outside the intervals indentified in the schedule attached to the Order.

Based on the Title V Hearing requests and other comments received by SCAQMD, as well as the expressed public interest in the RBEP permitting, SCAQMD held a public consultation meeting on June 25, 2015, at the Crowne Plaza Redondo Beach & Marina Hotel, 300 North Harbor Drive, Redondo Beach from 6:00 pm to 8:30 pm to receive further input from interested parties. The meeting was well attended by more than 60 public members, as well as staff from the Cities of Redondo Beach and Hermosa Beach and representatives from offices of elected officials. SCAQMD received several comments from approximately 30 individuals who spoke at the meeting and provided comments, including significant comments from the outside counsel and consultants hired by the City of Redondo Beach. SCAQMD anticipates completion of the Final Determination of Compliance (FDOC) within 30 days after the public meeting, however, the

timing may change due to the extent and contents of the air quality related comments and public input received both during the 30 days comment period for PSA and during the public meetings.
