**NOTICE OF COMMISSION ADOPTION HEARING, AVAILABILITY OF
15-DAY LANGUAGE AND OPPORTUNITY FOR COMMENT****Proposed Amendments to Title 20 Commission Process and
Procedure Regulations****Docket No. 15-OIR-1**

The Notice of Postponement¹ issued on May 13, 2015, set a date of July 8, 2015, for consideration and possible adoption by the commission of the proposed amendments to Title 20 of the California Code of Regulations relating to the commission's siting and process and procedures regulations. **The commission will not consider adoption of these matters on July 8, 2015, and the hearing date for consideration and possible adoption of the proposed amendments and an adoption of a notice of exemption under the California Environmental Quality Act has been postponed to July 30, 2015.** This will allow time for those interested to review and comment on the proposed 15-day language changes filed concurrently with this notice.

The public comment period on the 15-day language **will close at 4 p.m. on July 20, 2015.**

PUBLIC HEARING (Gov. Code, §11346.5(a)(1))

The commission will hold a public hearing for consideration and possible adoption of the exemption under the California Environmental Quality Act and the 15-Day Language on the following date and time unless the commission decides to modify the Express Terms through issuance of additional 15-Day Language.
