Proposed Amendments to Title 20 Commission Process and Procedure Regulations

Docket No. 15-OIR-1

On July 1, 2015, the commission issued proposed amendments, 15-day language, to Title 20 of the California Code of Regulations relating to the commission's siting and process and procedures regulations. Based on additional review of the proposed amendments, commission staff is proposing additional changes which are reflected in supplemental 15-day language and is available for public review.

The public comment period on the 15-day language **will close at 4 p.m. on August 28, 2015.**

PUBLIC HEARING (Gov. Code, §11346.5(a)(1))

The commission will hold a public hearing for consideration and possible adoption of the exemption under the California Environmental Quality Act and the supplemental 15-Day Language on the following date and time unless the commission decides to modify the Express Terms through issuance of additional 15-Day Language.
