Notice of Joint Agency Workshop on California's Drought Response

The California Energy Commission will lead a joint agency workshop to discuss the impacts of the drought on California and its energy system, and to gather information on partner state agencies' efforts in reducing these impacts. Chair Robert Weisenmiller is the Lead Commissioner for electricity and natural gas, and Commissioner Andrew McAllister is the Lead Commissioner for energy efficiency and the *2015 Integrated Energy Policy Report (2015 IEPR)*. This workshop is being held in conjunction with the California Public Utilities Commission Water-Energy Nexus Proceeding, Rulemaking 13-12-011, assigned to Commissioner Catherine J.K. Sandoval. Other Commissioners at the Energy Commission and the California Public Utilities Commission may also attend and participate in the workshop. Executive management from other state agencies may also attend, including but not limited to representatives from State Water Resources Control Board; California Environmental Protection Agency; Department of Water Resources; Department of Food and Agriculture; and the Governor's Office.

Public Comment

Oral Comments: Commissioners will accept oral comments during the workshop. Public comments may be limited to three minutes or less per speaker. Any comments will become part of the public record in the IEPR proceeding.

Written Comments: Written comments on the IEPR should be submitted to the Dockets Unit by 4:00 p.m. on **September 11, 2015**. All written comments will become part of the public record of the IEPR.
