Notice of Joint Agency Workshop on California's Drought Response

The California Energy Commission will lead a joint agency workshop to discuss the impacts of the drought on California and its energy system, and to gather information on partner state agencies' efforts in reducing these impacts. Chair Robert Weisenmiller is the Lead Commissioner for electricity and natural gas, and Commissioner Andrew McAllister is the Lead Commissioner for energy efficiency and the *2015 Integrated Energy Policy Report (2015 IEPR)*. This workshop is being held in conjunction with the California Public Utilities Commission Water-Energy Nexus Proceeding, Rulemaking 13-12-011, assigned to Commissioner Catherine J.K. Sandoval. Other Commissioners at the Energy Commission and the California Public Utilities Commission may also attend and participate in the workshop. Executive management from other state agencies may also attend, including but not limited to representatives from State Water Resources Control Board; California Environmental Protection Agency; California Air Resources Board; Department of Housing and Community Development; Department of General Services; Department of Water Resources; Department of Food and Agriculture; and the Governor's Office.

Background

In 2015, California entered its fourth consecutive year of drought, with severe water shortages impacting the state's communities, businesses, and environment. Within the energy sector, this included reduced electricity generation from hydroelectric facilities, as well as reduced water available for the cooling of thermal power plants. Information about the severity of the drought and California's actions to prepare for water shortages is available online at <http://www.ca.gov/drought/>.

In response to these conditions, Governor Brown issued Executive Order B-29-15 on April 1, 2015. This order included a 25 percent reduction in potable urban water use below 2013 levels through February 2016. The Executive Order also identified new water conservation programs to be administered by state agencies. Within the Energy Commission, this includes a water appliance rebate program and a water energy technology deployment program. The Executive Order also directed the Energy Commission to expedite the processing of amendments to power plant certifications for the purpose of securing alternate water supply. Finally, the Energy Commission has also adopted water efficiency standards for toilets, urinals, and faucets, which will become effective as of January 1, 2016. - Outlook and planning for the future.


