El Segundo Energy Center LLC ("**Project Owner**"), owner of the El Segundo Energy Center (00-AFC-14C) ("**ESEC**"), submits this status report for the ESEC Petition to Amend ("**PTA**") for proposed units 9-12.

On August 27, 2015, Energy Commission Staff published its Combined Final Staff Assessment Combined Parts A & B for the El Segundo Power Facility Modification Amendment to the El Segundo Energy Center ("Combined FSA"). The Combined FSA incorporated staff's evaluation of Air Quality into the previously issued FSA Part A and provided Staff's substantive responses to Project Owner's comments on the FSA Part A. The Combined FSA also made a number of changes to the proposed Conditions of Certification. Project Owner is in the process of evaluating the new Air Quality section, Staff's responses to comments, and the changes to the proposed Conditions of Certification. Notices of Availability for the Combined FSA were issued on September 11, 2015. Project Owner thanks the Staff for their diligent assessment of the PTA and looks forward to the setting of evidentiary hearing dates.

Project Owner would also like to inform the Committee tasked with evaluating the PTA that on September 2, 2015, Project Owner filed a 120 day notice of NPDES Permit modifications associated with the shutdown of the once-through cooling system at El Segundo Generating Station.
