Pursuant to the Committee Scheduling Order issued on May 6, 2014 and subsequent memorandum issued by the Hearing Advisor on April 21, 2015,¹ AES Southland Development, LLC (the “Applicant”) files this status report to inform the Committee on the progress of the Alamitos Energy Center (“Project”) Application for Certification (“AFC”) proceeding.

The Applicant expects to file the supplemental AFC (“SAFC”) on or about October 23, 2015. Therefore, the Applicant requests that the Status Conference currently scheduled for October 19, 2015 be postponed until early November, to allow all parties and the Committee a chance to review the SAFC prior to the Status Conference.

The Applicant also requests that the Committee consider adoption of the schedule proposed in Attachment A to this status report at the next Status Conference.
