### **Background**

On September 9, 2015, the Energy Commission adopted amendments to sections of Title 20 related to the Commission's general administrative process and procedures and power plant siting procedures (Docket 15-OIR-01). Continuing this effort, Energy Commission staff is now looking at issues important to compliance on jurisdictional power plants. Specifically, staff is looking to work with power plant owners and operators, federal, state, and local agencies, and other stakeholders to explore possible revisions to sections of Title 20 covering post certification processes, including section 1769 Amendments and section 1770 Compliance Verification. Energy Commission staff looks forward to working with stakeholders during this informal pre-rulemaking scoping period to frame issues and develop solutions.

## Topics to Consider

- How to reduce the number of amendments or time to process amendments
- If and when appropriate to allow more flexibility for staff approval of project changes where applicable
- Streamline and standardize compliance processes and reporting requirements
- Transparency of the compliance process and public participation
- Improving the implementation of Conditions of Certification

- Enforcement
