## Section 1601. Scope.

(h) Plumbing fittings, which are showerheads, lavatory faucets, kitchen faucets<u>that are consumer products</u>, metering faucets, replacement aerators, wash fountains, tub spout diverters, public lavatory faucets, and commercial pre-rinse spray valves.

## Section 1604. Test Methods for Specific Appliances.

## (h) Plumbing Fittings.

(2) The test methods for showerheads are:

(A) **Maximum flow rate test.** The test method for determining maximum flow rate of a showerhead is 10 C.F.R. section 430.23(<u>st</u>) (Appendix S to Subpart B of Part 430).

(3) The test method for <del>other plumbing fittings</del> <u>faucets</u>, <u>replacement aerators</u>, <u>and wash</u> <u>fountains</u> is 10 C.F.R. section 430.23(s) (Appendix S to Subpart B of part 430).

(5) The leakage rate test method for tub spout diverters is section 7.4.2 of ASME A112.18.1M-1996. A cycle of diverting is per Section 7.4.3 of ASME A112.18.1M-1996. Leakage rate shall be measured at 20 psi and 60 psi. The new leakage rates shall be reported as the highest measured leakage rate when new. The 15,000 cycles leakage rate shall be reported as the highest measured leakage rate when the tub spout diverter has completed 15,000 cycles.

<sup>1</sup> The maximum flow rate shall be the highest value obtained through testing at a flowing pressure of  $80 \pm 1$  psi and shall not exceed the maximum flow rate in Table H-5.

<sup>2</sup> **Minimum flow rate.** The minimum flow rate, determined through testing at a flowing pressure of  $20 \pm 1$  psi, shall <u>be</u> not <del>be</del> less than 60 percent of the <u>measured</u> maximum flow rate at <u>80-psi</u> in Table II-5. The minimum flow rate determined through testing at flowing pressures of 45 and 80 ± 1 psi shall <u>be</u> not <del>be</del> less than 75 percent of the <u>measured</u> maximum flow rate <u>at 80 psi</u> in Table II-5.

<sup>3</sup> **Showerheads with multiple nozzles.** The total flow rate of showerheads with multiple nozzles must be less than or equal to the maximum flow rate in Table H-5 when any or all nozzles are in use at the same time.
