Dear Mr. Kluesener:

I am in receipt of your request dated November 17, 2015 for expedited processing and approval for emergency reconstruction activities at the Geysers Power Company Socrates (Unit 18) Geothermal Project (79-AFC-3C) that will include the repair, reconstruction, and/or replacement-in-kind of the cooling tower damaged in the recent Valley Fire.

In response to the wildfires in California, Governor Brown issued Executive Order B-36-15, which addresses the damage caused to critical infrastructure, including power plants. The Executive Order states in part that "[t]he Energy Commission shall expedite the processing of all applications or petitions for amendments to power plant certifications issued by the Energy Commission for the purpose of remediating any wildfire damage and to restore power plant operation by authorizing emergency construction activities including demolition, alteration, replacement, repair or reconstruction necessary for power plant operation. Title 20, section 1769 of the California Code of Regulations is hereby waived for any such petition, and the Executive Director of the Energy Commission shall approve such petitions as he deems necessary."

The Executive Order further states "[f]or purposes of carrying out directives in this Executive Order, Division 13 (commencing with section 21000) of the Public Resources Code and regulations adopted pursuant to that Division are hereby suspended."

I have read and considered your request for approval of emergency reconstruction of the Geysers Power Company Socrates (Unit 18) cooling tower. Pursuant to Executive Order B-36-15, based on the information you have provided in your letter and attachments, I deem the requested reconstruction to be necessary to remediate the wildfire damage to your facility and to restore power plant operations.

I hereby authorize the emergency construction activities including demolition, alteration, replacement, repair and/or reconstruction of the cooling tower and related structures as required.

Please be advised that upon the completion of the Authority to Construct by the Northern Sonoma County Air Pollution Control District, I will take appropriate action on your request to approve the addition of an administrative air quality condition of certification.
