**PETITION FOR OWNERSHIP
TRANSFER FROM PALEN SEGS I,
LLC, TO MAVERICK SOLAR, LLC**

Palen SEGS I, LLC (“Palen SEGS I”) hereby petitions the Commission to transfer ownership of the Commission Decision on the Palen Solar Power Project (CEC-800-2010-010 CMF, Docket No. 09-AFC-07, Order No. 10-1215-19) (“PSPP”) from Palen SEGS I to Maverick Solar, LLC, a Delaware limited liability company (“Maverick”). In accord with 20 CCR 1769(b), this Petition includes the following information:

- (A) a discussion of any significant changes in the operational relationship between the owner and operator;
- (B) a statement identifying the party responsible for compliance with the commission’s conditions of certification; and
- (C) a statement verified by the new owner or operator in the same manner as provided in Section 1707 that the new owner or operator understands the conditions of certification and agrees to comply with those conditions.

Changes in Operational Relationship Between Owner and Operator

On December 15, 2015, Maverick and Palen SEGS I agreed to transfer ownership of the PSPP to Maverick. Subject to the satisfaction of the terms of that agreement and approval by the United States Bankruptcy Court for the District of Delaware, Maverick will be the owner of the PSPP.

Party Responsible for Compliance with the Commission’s Conditions of Certification

Upon becoming the owner of PSPP, Maverick will be responsible for compliance with the conditions of certification, and agrees to comply therewith. Maverick's legal address and contact person are:
