**SACRAMENTO COGENERATION AUTHORITY'S PETITION TO
CHANGE OPERATIONAL CONTROL OF THE PROCTER & GAMBLE
COGENERATION PROJECT**

I. Introduction

Pursuant to California Code of Regulations, Title 20, section 1769(b), Sacramento Cogeneration Authority (SPA) submits this petition to change operational control of the Procter & Gamble Cogeneration Project, a combined cycle natural gas-fired power plant located in Sacramento County. This proposed change in operational control proposes no changes to any conditions of certification; nor will such a change affect the analyses in the California Energy Commission's Final Decision and subsequent decisions on amendments thereto. Section 1769(b) requires this petition to discuss any significant changes in the operational relationship between the owner and operator; identify the party responsible for compliance with the Commission's conditions of certification; and verify that the new operator understands the conditions of certification and has agreed to comply with those conditions.

II. Discussion

Pursuant to a competitive solicitation process, SPA has retained EthosEnergy Power Plant Services, LLC (EthosEnergy) to operate the Procter & Gamble Cogeneration Project, taking the place of the project's previous operator, Carson Energy Group.

The Sacramento Cogeneration Authority is the party responsible for compliance with the conditions of certification. Attached is a verified statement from an authorized officer of Ethos Energy stating that EthosEnergy understands and has agreed to comply with the conditions of certification.


