Women In Non Traditional Employment Roles (W.I.N.T.E.R.) Rosie the Riveter implements the North America's Building Trades Unions Apprenticeship Readiness Training for disadvantaged youth utilizing High School education, multi-trade curriculum, case management apprenticeship placement, mentorship and retention services to increase the number of disadvantaged youth workers prepared to compete with the skills necessary to work in the construction and building trades. This initiative is designed to ensure that the program meets today's and future hiring needs of local industry and registered apprenticeships and *to level the working field for disadvantaged youth workers.*

ALL students participate in both the High School and vocational training.

Our program is in session Mon-Friday from 8:00am - 4:30pm

Vocational Training is for 12 months and the Academic program is Sept-June

Our Charter school is Youthbuild Charter School of CA chartered by Inyo County School District.

Our current enrollment is 64 students in grades;

- 9 - 11
- 10- 18
- 11-19
- 12- 16
