## Re: Alamitos Energy Center (13-AFC-01): Removal of Temporary Secondary Construction Access Road

Dear Mr. Meyer:

AES Alamitos Energy, LLC (AES)<sup>1</sup>, the Applicant, submits this supplemental information for the Alamitos Energy Center (AEC) located in the City of Long Beach, California. A Supplemental Application for Certification (SAFC) was filed on October 26, 2015.

As discussed at the February 11, 2016 Status Conference, the Applicant confirms the need to remove references to the temporary secondary construction access road for the AEC as shown in AEC SAFC Figure 1.1-3. Securing the necessary rights for the temporary construction access road is not feasible. The Commission's analysis should reflect access to the AEC site during construction and operation through the main Alamitos Generating Station gate off of Studebaker Road. The removal of the temporary construction access road will not alter the Applicant's plan for the secondary emergency access for AEC, and the information required for the analysis of the main gate access is in the SAFC.

We recommend that the following references to the temporary secondary construction access road that should also be removed in the Staff's SAFC review:
