STATUS UPDATE No. 4

Staff continues to work to file the Preliminary Staff Assessment on March 21, 2016. Since the last status report of February 19, 2016, staff has had periodic discussions with the Project Owner, with the EPA, and with the Antelope Valley Air Quality Management District for issue clarification.
