

  - e. What are the roles of CDFW, Mojave Water Agency (MWA), and VVWRA in ensuring no impacts to the Alto Subbasin from recycled water use?
- 2. What needs to be done to obtain a current water balance calculation from MWA?
  - a. What is the timing to receive such a calculation?
  - b. Is there a cost?
  - c. Who would bear the cost?
  - d. What are the outcomes and proposed approaches to analysis and mitigation, if needed, for recycled water use?
- 3. Is interim relief needed from the 2014 Energy Commission Order limiting HDPP to use no more than 2,000 acre feet of adjudicated groundwater from the Mojave River Basin after September 30, 2016?
  - a. If yes, what are the options available to the Energy Commission for providing interim relief to the Petitioner?
  - b. What level of authority can and should provide such relief in this situation?
  - c. Which conditions of certification, if any, require change to provide the relief?

- d. What length of time is necessary for such interim relief?
- e. What amount of groundwater use can be written into a condition of certification? Currently, the proposed loading order says the MWA groundwater is the "4<sup>th</sup>" project supply, but nothing prevents the project from using up to 3,090 Acre Feet per Year (AFY).
- f. Regarding issues related to replacing banking by injection with banking by percolation through MWA how should the Conditions of Certification be modified, ie, the Petitioner's proposal vs staff counter proposal?
- 4. What has been the historic water demand and usage of the HDPP?
  - a. What future assumptions are appropriate regarding capacity factors for the HDPP, water quality and quantity, and weather, as they relate to the Petition?
- 5. What process and procedure should the Committee use to protect confidential data that may be needed in addressing the Petition, including the staff analysis of the feasibility study?
