Good afternoon Matt,

Thanks for the email below requesting scheduling, and courtesy copies of the PDOCs for Huntington Beach and Alamitos. For clarification purposes, we have given equal priority for both projects. The Huntington Beach project was submitted to SCAQMD on September 8, 2015 while the Alamitos project was submitted on October 23, 2015. As can be appreciated, the Huntington Beach project is six weeks further along due to the timing of their submittal. As with the initial application submittal, Huntington Beach's request for modification came in before Alamitos, hence, Alamitos is still in arrears to Huntington Beach.

The Huntington Beach project is currently under review by our first level supervisor and we expect that process along with secondary supervisory review to be completed before the end of May 2016, we are striving to have the PDOC completed as quickly as possible. Once the first level supervisor review is complete, we can provide a courtesy copy of the draft PDOC. Please advise who would be the proper person to send this document to.

The Alamitos project is currently being reviewed by our staff for air modeling analysis and health risk assessment. Please note that we received the necessary information for these changes just a few weeks ago. Even with that being said, we believe that we will be able to complete the entire review of the PDOC before the end of June 2016, again, we are striving to have the PDOC completed as quickly as possible. Once the first level supervisor review is complete, we can provide a courtesy copy of the draft PDOC. Please advise who would be the proper person to send this document to.

Please note that any courtesy copy of PDOC that we send to CEC, is still a draft internal document that SCAQMD is willing to share with CEC in order to facilitate meeting the expedited schedule for the CEC process. However, any such draft PDOC is for CEC staff's review only and is not to be released outside your agency, until we have completed our review of the PDOC and issued a formal version of the document.

**Subject:** DOCs for Alamitos and Huntington Beach

Mohsen and Andrew,

We just had a status conference for Huntington Beach. AES reported that the PDOC is imminent, but AES wanted the committee to check with the District. The Committee deferred, saying it might appear to violate our Ex Parte Rule. They in turn asked staff to contact you to find out the current schedule for release of the PDOC for the amended HBEP. For the amended HBEP PDOC, do you have a schedule, what is that schedule, and can we get a courtesy copy so we can start our incorporation into our PSA as soon as possible?

Another item that came up today was that HBEP should not be a priority over Alamitos, according to AES. The retirement of HBGS coupled with the demise of SONGS resulted in HBGS coming back on line, and later, some HBGS units converting to synchronous condensers. This focus (ie, the locational value of HB) seems to have carried forward where all of us were thinking that HBEP was the priority over AEC. AES clarified today that both should be given equal priority, or AEC should have the priority. This stems from the facts that AES has access to the HBEP site from the approved version to begin preliminary work and demo, while they do not have access to the AEC site as no decision has been adopted.

So, for the AEC PDOC, do you have a schedule, what is that schedule, and can we get a courtesy copy so we can start our incorporation into our PSA as soon as possible?

Please note that the committee asked that we docket your response so the record is clear on your DOC status.
