## PETITION TO TRANSFER OWNERSHIP of the MIDWAY SUNSET COGENERATION STEAM DISTRIBUTION LINE (85-AFC-3C)

On April 13, 2016, the Midway Sunset Cogeneration Company (MSCC) filed a petition with the California Energy Commission to transfer the ownership the remaining portion of the main steam distribution line at the Midway Sunset Cogeneration project (Midway Sunset or project) to the steam host, Aera Energy, LLC. The 225 megawatt project was certified by the Energy Commission on May 14, 1987, and began commercial operation on May 1, 1989. Midway Sunset is a cogeneration facility that produces steam to aid in an enhanced oil recovery process, and is located in Fellows, Kern County, California.

The request would transfer responsibility for compliance with the Conditions of Certification to Aera Energy, LLC. A statement describing the change in ownership, signed under penalty of perjury by a representative of Project Energy, LLC, was submitted as required by Title 20, California Code of Regulations, section 1769(b). The statement affirms that the new owner understands the obligations imposed by the Conditions of Certification and agrees to be bound by the requirements of the Energy Commission's Decision for the project. The Energy Commission may approve changes in ownership or operational control after 14 days notice. Based on the information provided, Energy Commission staff intends to recommend approval of the petition at the June 8, 2016, Business Meeting of the Energy Commission.
