ORDER ACCEPTING THE EXECUTIVE DIRECTOR'S RECOMMENDATION TO FIND
THE MISSION ROCK ENERGY CENTER APPLICATION FOR CERTIFICATION (AFC)
DATA ADEQUATE

On December 30, 2015, Mission Rock Energy Center, LLC, filed an Application for Certification (AFC) to construct and operate an electrical generating facility in Ventura County, California, approximately 2 miles west of Santa Paula, near State Highway 126.

The Mission Rock Energy Center (Mission Rock) would be a natural gas-fired, nominal 255-megawatt electrical generating facility. Mission Rock would also provide 100 MWhr of battery storage and synchronous condenser clutch technology to provide ancillary and grid reliability services.

Energy Commission Staff completed its initial data adequacy review of the AFC in accordance with the California Code of Regulations, title 20, section 1704, and Division 2, Chapter 5, Appendix B for the 12-month permitting process. On January 29, 2016, the Energy Commission adopted the staff's recommendation that the information contained in the AFC was deficient in eleven areas, namely: air quality, biological resources, cultural resources, project overview, reliability, soils, traffic & transportation, transmission system design, visual resources, waste management and water resources.

On April 29, 2016, the Applicant submitted supplemental information reviewed by staff, and the Executive Director presented a revised recommendation that the AFC now contains all the information required by California Code of Regulations, Title 20, Section 1704, including Appendix B, for the 12-month AFC process.

On this basis, the Energy Commission hereby accepts the Mission Rock AFC with the supplemental information as data adequate, and pursuant to California Code of Regulations, Title 20, Section 1709 (c), deems the AFC complete.
