### Subject: PUENTE POWER PROJECT (P3) STATUS REPORT 7

In accordance with the Scheduling Order issued by the Committee on April 27, 2016, staff is submitting Status Report 7.

#### **Project Activities**

No substantive project activities or developments have occurred since the release of Status Report 6. On April 27, 2016, the Committee granted the Petition to Intervene filed by California Environmental Justice Alliance.

Staff anticipates the following project activities in the period before the next Status Report scheduled for June 24, 2016:

- Publication of the Preliminary Determination of Compliance (PDOC) by the Ventura County Air Pollution Control District (VCAPCD) by May 31, 2016; and
- Publication of the PSA on June 15, 2016.

#### **Other Activities**

The city of Oxnard is moving forward on a General Plan Amendment that would prohibit electric generating facilities greater than 50 MW from locating in areas subject to designated coastal and other environmental hazards. On May 5, 2016, the Planning Commission voted to recommend approval of the General Plan amendment to the City Council, which is scheduled to consider the matter on June 7, 2016. Should the amendment be approved before publication of the Final Staff Assessment (FSA), staff's Land Use analysis will address the proposed changes relative to P3.

#### Project Schedule

Staff has updated the project schedule to be consistent with the Committee's Scheduling Order, with the exception that two weeks has been added to the timeframe for VCAPCD's publication of a PDOC and Final Determination of Compliance (FDOC). Staff anticipates meeting all of the prescribed timeframes for publication of the PSA and for holding a PSA workshop in Oxnard.
