

## **Energy Commission's Role**

- Energy Commission has exclusive permitting authority over thermal power plants that are 50 megawatts (MW) or greater. Power plants that generate less than 100 MW may be exempted under Public Resources Code section 25541 (SPPE).
- The Energy Commission has a certified regulatory program and is the lead state agency for California Environmental Quality Act (CEQA) review and ongoing compliance.
- The Energy Commission has appointed Commissioners Janea Scott (Presiding Committee Member) and Karen Douglas (Associate Committee Member) to oversee the SPPE process for this project.



## Pomona Repower Project

- March 21, 2006: AltaGas Pomona Energy, Inc., filed an Application for an SPPE to construct and operate the PRP.
  - 100 MW natural gas-fired, simple-cycle electric generating plant, built at the existing 44.5 MW San Gabriel Cogeneration Facility.

### **Committee Action**

- The Commissioners presiding over this proceeding will eventually issue a proposed decision.
- Review is similar to an initial study under CEQA.
- Open to the public.



#### **Ex Parte Rule**

- Purpose: to provide full disclosure to all participants of any information that may be used as a basis for the future Decision on this project.
- All decisions made in this case will be made solely on evidence contained in the <u>public record</u>.
- No off-the-record contacts concerning <u>substantive</u> matters are permitted to take place between interested parties and the Commissioners, their Advisors, this Committee, or the Hearing Officer.



#### **Ex Parte Rule**

Contacts between interested parties and the members of the Committee regarding any substantive matter must occur in a <u>public forum</u> or in written form distributed to all the parties and made available to the public.



## **Environmental Review**

- Energy Commission staff are an independent party in the proceeding. Staff will prepare an independent evaluation of the environmental, engineering, and public health/safety aspects of the proposed project and whether the project would conform to all applicable laws, ordinances, regulations and standards (LORS).
- Commission Staff may hold public workshops at locations near the site or at the Energy Commission in Sacramento. These workshops provide additional opportunities for the parties and governmental agencies to discuss substantive issues with the public.

- Prehearing Conference
- Evidentiary Hearings
- Committee's Proposed Decision (public comment opportunity)
- PMPD hearing and full Commission decision






#### **Staff Analysis Process**

- Send Data Requests (DRs) to Applicant (completed April 27, responses due May 27)
  - DRs sent covering the following issue areas: air quality, biological resources, hazardous materials management, socioeconomics, traffic and transportation, transmission system engineering, visual resources/plume analysis, waste management, and water resources
- Prepare Issue Identification Report including PM proposed schedule (completed May 6)
  - Issues identified in the areas of Air Quality and Transmission System Engineering
- Facilitate public and agency participation (various types of notices completed during April and May, workshops if necessary)



 Produce a Draft Initial Study and Final Initial Study, both of which include a Negative Declaration or Mitigated Negative Declaration recommendation

## **Discovery and Analyses Process**



#### Local, State and Federal Coordination

- Energy Commission staff work closely with other Local, State and Federal Agencies, for example:
  - Local: City of Pomona--Fire Department, Planning Department
  - Regional: Los Angeles County, South Coast Air Quality Management District, Los Angeles Regional Water Quality Control Board
  - State: California Department of Fish and Wildlife, CalTrans, CalOSHA
  - Federal: Environmental Protection Agency, Fish and Wildlife Service




#### **Evidentiary Hearing & Decision Process**

- Committee conducts Hearings to create Evidentiary Record
- The Committee issues the Committee's Proposed Decision. This document contains findings relating to:
  - Environmental impacts
  - Energy impacts
  - The ultimate recommendation whether or not to approve the exemption
- Full Commission issues a Final Decision on the exemption request
- Appeals: Reconsideration by Commission; California Supreme Court



#### **Evidentiary Hearing & Decision Process**



#### Staff's Issues Identification Report

#### Purpose

- Inform participants of potentially significant issues staff believes it will encounter
- Provides an early focus on important topics
- The Issues Identification Report is not limiting. Staff, agencies and other stakeholders may identify additional significant issues going forward.

#### Criteria for Significant Issue

- Significant impacts that might result from the project that may be difficult to mitigate
- Conflicts might arise between the parties about the appropriate findings
- Issues that might delay the SPPE analysis process



#### Staff's Potential Issue Areas

Energy Commission staff has evaluated the SPPE application and has found potential major issues with:

- Air Quality
- Transmission System Engineering

Discovery is not yet complete and other parties may identify their concerns.



## **Air Quality**

- Insufficient Offsets for Air Quality Mitigation
- ■The application describes the methodology to be used for the cumulative effects analysis but does not include the analysis itself because a final project list had not been provided by the District at the time the SPPE application was prepared and submitted to the Energy Commission.
- ■Staff believes that these air quality issues could potentially delay the Energy Commission review process or prevent staff from concluding that the project would not have a substantial adverse impact on the environment.
- Staff issued Air Quality Data Requests to address these potential issues, and applicant will provide responses by May 27.



## **Transmission System Engineering**

- The California ISO Phase I and Phase II Interconnection Studies are not available for staff to review. The Phase I Study is required for staff to determine the potential need for downstream transmission facilities.
- If the studies show the project would cause any transmission line overloads which might require transmission line reconductoring or other significant downstream upgrades, a general CEQA analysis will be required. The environmental analysis of potential upgrades could cause a delay in the exemption analysis process for the Pomona Repower Project (PRP).
- Staff has submitted Data Requests requesting Phase I and Phase II Interconnection Studies. Data responses due May 27.

## Two Levels of Public Participation

#### Importance of Public Participation through Public Comment

- Public comments are considered by the Commissioners
- Public comments help inform the Commissioners, staff, and interested parties of public concerns
- Public comments are necessary to understand the concerns of residents
- Public comments are not considered evidence but are part of the official record

## Two Levels of Public Participation

#### First Level - Public Comments (Informal Participation)

- Verbal comments at public meetings through Blue Cards
- Electronic comments through the Energy Commission e-filing system
- Written comments to the Energy Commission Dockets Unit:

## Two Levels of Public Participation

#### Second Level - Intervening (Formal Participation)

- An Intervenor is a party to the proceeding
- Anyone may file a Petition to Intervene
- You do not have to be or have an attorney to intervene
- > The PAO can provide a sample Petition to Intervene
- Petition is considered by assigned Committee; determination within 30 days
