**Project Description:** The 330-megawatt combined cycle generating facility was certified by the Energy Commission on March 24, 2010, and began commercial operation on November 1, 2012.

**Modification Description:** Transfer of ownership from GWF Energy LLC to AltaGas San Joaquin Energy Inc., and transfer of operational control to AltaGas Tracy Operations Inc.

On April 13, 2016, the California Energy Commission (Energy Commission) approved the above-described transfer of ownership and operational control pursuant to a regulatory program certified by the California Secretary of Resources under Section 21080.5 of the California Public Resources Code.
