Renewables Portfolio Standard Verification Report

The Renewables Portfolio Standard 2011-2013 Retail Sellers Procurement Verification Lead Commissioner Report (RPS 2011-2013 Retail Sellers Verification Report) details the Energy Commission's Renewables Portfolio Standard (RPS) procurement verification findings for retail sellers of electricity under California's RPS.

The Energy Commission prepares verification reports as part of its RPS responsibilities. Upon finalization of the *RPS 2011-2013 Retail Sellers Verification Report*, the Energy Commission will transmit its RPS procurement verification findings to the California Public Utilities Commission (CPUC).

This report provides the following information:

- Indicates the eligible, ineligible, and withdrawn RPS procurement claims for each retail seller and provides the total amount of eligible RPS procurement.
- Verifies, to the extent possible, that RPS procurement exclusively serves California's RPS and does not support another renewable energy regulatory or market claim.
- Provides analysis of RPS-eligible claims by resource type.
- Discusses the limitations and future outlook of the Interim Tracking System (ITS) and verification process.

Process

To date, the Energy Commission has published verification reports for compliance years 2004, 2005, 2006, 2007, and 2008-2010. The scope of the *RPS 2011-2013 Retail Sellers Verification Report* includes procurement data and findings for the following 21 entities:

As appropriate, staff incorporated the stakeholder comments, and updated findings on the RPS claim eligibility. These changes are reflected in this *RPS 2011-2013 Retail Sellers Verification Report.*
