**PALMDALE ENERGY, LLC's STATUS
REPORT 8**

In accordance with the Committee Scheduling Order dated December 2, 2015, Palmdale Energy, LLC has prepared this Status Report 8 to inform the Committee and to provide recommendations concerning the processing of the Petition For Amendment for the Palmdale Energy Project (PEP). The following summarizes the status of the Commission process since the last status report which was filed on June 15, 2016.

Final Determination of Compliance

The Antelope Valley Air Quality Management District (District) published its Revised Preliminary Determination of Compliance on May 13, 2016. The public comment period closed on June 13, 2016 and the only comment letter Palmdale Energy, LLC has received was from USEPA. Palmdale Energy, LLC believes that the Final Determination of the Compliance (FDOC) will likely be released the week of July 25th.

Los Angeles County Department of Public Works

As described in Status Report 7, Palmdale Energy, LLC prepared a map showing the potential transmission line crossings that would be subject to a Franchise Agreement and has sent the map to Los Angeles County Department of Public Works (LACDPW) for their review. Additionally, Palmdale Energy, LLC submitted the following proposed Condition of Certification for LACDPW review. LACDPW approved the Condition of Certification and therefore, Palmdale Energy LLC requests CEC Staff include it in its Final Staff Assessment.

LAND-1 The project owner shall enter into a Franchise Agreement with the County of Los Angeles for the following portions of the transmission line that will cross County of Los Angeles public roadways:

- Two crossings over the Sierra Highway
- Four crossings over the Angeles Forest Highway
- One crossing over Vincent View Road

Verification: At least 15 days prior to construction of any of the crossings identified above, the project owner shall provide a copy of the approved Franchise Agreement(s) with Los Angeles County to the CPM.

Cultural Resources

Palmdale Energy, LLC's consultant completed the cultural resources evaluation report identified in the Preliminary Staff Assessment and docketed it as confidential. This was the only outstanding item that Cultural Staff requested from Palmdale Energy, LLC in order to complete its section of the FSA.
