Subject: Revised Renewable Portfolio Standard Presentation

Please find enclosed an advance copy of the Department of Water and Power's <u>revised</u> presentation with respect to a proposed Renewable Portfolio Standard ("RPS"). We anticipate formally presenting this material to your Committee on June 22, 2004.

For your information, the presentation materials have been revised to incorporate preliminary feedback received from your Committee at the June 8, 2004 public hearing. The principal changes are as follows:

- Page 2 Added an interim goal that calls for achieving 13% renewables by 2010, and clarified that DWP may take an ownership interest in new renewable generation facilities and/or enter into renewable power purchase contracts
- Page 3 Added "Ocean Wave Technologies" as an eligible renewable resource
- Pages 6 and 7 Eliminated the "hypothetical" 14 cents and the 6 cents per kilowatthour scenarios that were confusing, and added descriptions and text boxes to help clarify the charts
- Page 9 Added "Impact on Local Economy and Jobs" as an additional parameter for evaluating and ranking potential renewable proposals

- Page 10 Clarified that a fixed 1.5% annual escalation rate was applied to the proposed 7 cents per kilowatt-hour maximum price that DWP would pay for renewables; a fixed escalation rate is required to establish a fixed maximum surcharge
- Page 11 Accelerated the schedule for "Soliciting Feedback from Key Stakeholders", including Neighborhood Councils
