**NOTICE OF RECEIPT
PETITION TO AMEND COLUSA GENERATING STATION (06-AFC-09C)**

On June 28, 2016, DayZen LLC, on behalf of Pacific Gas and Electric Company (PG&E), filed a petition with the California Energy Commission (Energy Commission) requesting modifications to the Colusa Generating Station (CGS). CGS is a 660-megawatt combined cycle facility located in an unincorporated area of Colusa County, six miles north of the community of Maxwell. The project was certified by the Energy Commission on April 23, 2008; and construction was initiated on October 2, 2008.

DESCRIPTION OF PROPOSED MODIFICATIONS

The PG&E petition (TN 212004) is seeking approval to modify the CGS to: 1) add a new warehouse; 2) add electrical equipment and three electrical cabinets to allow gradual increase of load to the electric motors for each fan on the Air Cooled Condenser (ACC); and 3) install rotating intake screens to control algae blooms at the water intakes for the Tehama Colusa Canal (TCC).

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

Energy Commission staff is currently reviewing the petition. The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and on public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and a determination on whether the facility, as modified, would remain in compliance with applicable laws, ordinances, regulations and standards (20 Cal. Code of Regs., § 1769). After the staff has completed its independent review and analysis of this petition, it will publish its assessment for public review and comment. Upon completion of its review, the staff will provide written notice of its intent to either process the proposed changes as a Staff Approved Project Modification or schedule it for consideration by the Energy Commission at a regularly scheduled Business Meeting.

This Notice of Receipt has been mailed to the Commission's facility mail list of interested parties and property owners adjacent to the facility site. It has also been emailed to the facility listserv. The listserv is an automated Energy Commission e-mail system by which information about this facility is e-mailed to parties who have subscribed. scroll down the right side of the project's webpage to the box labeled "Subscribe," and provide the requested contact information.

Any person may comment on the petition. 
