Basic Areas of Confusion

Applicant states that Section 1716 does not require the applicant to conduct "Research or Analysis" on behalf of the requesting party. Section 1710 defines *information* as including facts, data, measurements, calculations and analyses related to the project.

Applicant cites Carlsbad Decision, which stated: "The line between discoverable data and undiscoverable analysis and research is dependent on the particulars of a request and can not be drawn with precision." (2008)

Staff contends:

- · Research is the means by which cultural resource professionals gather information.
- The applicant has already conducted research and analysis but not substantiated recommendations with sufficient data or necessary fieldwork.
- Staff is requesting information from the applicant, not analysis. Staff will analyze
 this information to draw conclusions.

- I. Data Requests asks for:
 - 1 Technical Memorandum
 - 3 Technical Reports
 - Four Deliverables Summarized in DR 29-32
- II. Applicant miscounted
 - 3 Technical Reports
 - 5 Supplemental Reports
- III. Applicant may submit 1 report if they would like, provided it is organized per the request and includes the requested information.




Data Request 30 (DR 35-47)









Briggs, Santa Paula Y Saticoy: Road and Ditch Map, 1915


Map of Limoneira Co. Property, The Limoneira Company: One Hundred Years and Growing: 1893-1993
