WHEREAS, the City of Los Angeles Department of Water and Power (LADWP) entered into a long-term, natural gas transportation agreement with the Kern River Gas Transmission Company (KRGT)(DWP Agreement No. 10870) on April 2, 1990, providing the LADWP with firm, natural gas interstate pipeline transportation service from various points of receipt in Wyoming to a point of delivery in California, for a 15-year term beginning on March 1, 1992, and ending on February 28, 2007, at rates approved by the Federal Energy regulatory Commission (FERC); and,

WHEREAS, on October 23, 1998, the KRGT proposed to offer firm natural gas transportation service with Term Differentiated Rates (TDR) to be incorporated through proposed TDR rate schedules for a 15-year term following FERC approval of the TDR rates beginning on or near October 1, 2001, and ending on or near September 31, 2016; and,

WHEAREAS, on November 13, 1998, the LADWP executed a Letter of Intent with KRGT in which the LADWP indicated its interest in obtaining a 15-year TDR service from KRGT; and,

WHEREAS, on April 7, 1999, the Los Angeles City Council (Reference File No. 99-0283) authorized the LADWP to enter into a TDR Precedent Agreement with KRGT in which the LADWP would receive lower gas transportation rates in exchange for extending the term of its gas transportation contract with KRGT; and

WHEREAS, on December 20, 1999, KRGT has offered to enter into a newly substituted TDR Precedent Agreement that provides enhanced provisions favorable to the LADWP; and

WHEREAS, the KRGT is willing to provide, and the LADWP is willing to receive such TDR service subject to the satisfaction of conditions specified in the newly revised TDR Precedent Agreement (DWP Agreement No. BP 99-002A); now therefore,

BE IT RESOLVED that the newly revised TDR Precedent Agreement (BP 99-002A), by and between the KRGT and the LADWP, now on file with the Secretary of the Board and approved as to form and legality by the City Attorney, be and the same is hereby approved; and, BE IT FURTHER RESOLVED that the General Manager, Assistant General Manager – Marketing and Customer Service, the Assistant General Manager – Bulk Power, be and they are hereby authorized to execute the TDR Precedent (BP 99-002A), approved as to form and legality by the City Attorney, and now on file with the Secretary of the Board, be and the same are hereby approved.

BE IT FURTHER RESOLVED that the Chief Accounting Employee, upon proper certification, is authorized and directed to draw demands on the Power Revenue Fund in payment of obligations arising under this Agreement BP 99-002A.
