WHEREAS, The City of Los Angeles Department of Water and Power (LADWP) depends on the natural gas distribution system of the Southern California Gas Company to transport gas to the LADWP's Los Angeles basin generating stations (Harbor, Haynes, Scattergood, and Valley) for the production of electricity; and

WHEREAS, The Southern California Gas Company has been given the exclusive right by the State of California to provide natural gas transportation services to all electric utility customers in its service territory. These transportation services are provided through the execution of a standard Master Services Contract, approved by the California Public Utilities Commission, describing the customer's vital information such as expected gas usage at each generating facility, meter identification and the kinds of additional services, if any, the electric utility customer may require; and

WHEREAS, the Southern California Gas Company has offered to provide gas transportation services to the LADWP, contingent upon the LADWP executing a Master Services Contract prior to receiving the services to its Los Angeles basin generating stations.

NOW, THEREFORE, BE IT RESOLVED, that the attached LADWP Agreement No. 47498-6 which includes four copies of Attachment A – one for each LADWP generating station (Harbor, Haynes, Scattergood, and Valley), is approved as to form and legality by the City Attorney and filed with the Secretary of the Board, between the Department of Water and Power of the City of Los Angeles and Southern California Gas Company, be and the same is hereby approved; and

**BE IT FURTHER RESOLVED** that the Agreement No. 47498-6 is exempted from the provisions in Section 10 of the Los Angeles Administrative Code that pertain to the Child Support Policy, Recycled Paper, the Minority and Women Business Enterprise Outreach Program, Service Contract Worker Retention Living Wage Policy, and the Right to Audit requirement.

**BE IT FURTHER RESOLVED** that the President or the Vice President of this Board, or the General Manager, or such person as the General Manager shall designate in writing, and the Secretary, Assistant Secretary, or the Acting Secretary of the Board be and they are hereby authorized and directed to execute said Agreement for and on behalf of the LADWP upon approval by the Los Angeles City Council pursuant to City Charter Section 373.

**BE IT FURTHER RESOLVED** that this matter is forwarded to the City Council for approval pursuant to City Charter Section 373.

**BE IT FURTHER RESOLVED** that the Chief Accounting Employee of the LADWP, upon proper certification, is authorized and directed to draw demands on the Power Revenue Fund in payment of the obligations arising under this Agreement.
