**SECOND SUPPLEMENTAL DECLARATION OF LOUIS C. TING**

I, Louis C. Ting, declare as follows:

- 1) I am the Director of the Power System Planning and Development Division at the Los Angeles Department of Water and Power (LADWP). I graduated from the University of California at Los Angeles with a Bachelor of Science in Mechanical Engineering in 1992. I am a California licensed Professional Mechanical Engineer. I have worked at LADWP since 1992.
- 2) As the Director of the Power System Planning and Development Division at LADWP, my responsibilities include the management and oversight of LADWP's regulatory standards and compliance division, such as LADWP's compliance with its renewables portfolio standards (RPS) program. I am familiar with LADWP's submissions to the California Energy Commission (CEC) relating to LADWP's renewable resources and procurement. On July 22, 2016, I submitted my first declaration in 16-RPS-02, TN# 212401. On August 30, 2016, I submitted my supplemental declaration in 16-RPS-02. I am authorized to make this second supplemental declaration on behalf of LADWP and the following matters are true and accurate to the best of my knowledge and belief.
