## **We Will Be Energy Secure with Aliso Canyon Shut Down**

I am a resident of Porter Ranch, who for the past year has had my life entirely changed for the worse, due to the leaks, prior, on October 23, 2015, and post. We now know that none of the wells passed inspection due to SB380, which means they were all leaking prior to October 23, 2015. My health and that of my dog have been severely affected by chemicals still unknown, that have entered my home, and possibly land and water. I evacuated after two solid months of trying to find a place to relocate, it was not easy, but very necessary. My home was not cleaned properly afterwards by contractors of SoCalGas, and I have had to continually leave what I had thought was my dream home.

I'm saddened by the lack of help to those who are so sick due to toxic exposure. I am saddened that my ability to work has declined to nothing, my income depleted by not being able to even lease my home due to strong health affects in and around the home. Visitors become sick entering my home, or standing in the front of my home. Why?

SoCalGas lied about having safety valves for years, and they are still not required. Reliance capability must include the threats and effects to humans, animals and the environment.

Mitigation efforts are working. We have had no black outs with Aliso Canyon shut down, even in our hottest June in history. The public would save \$70M/year by closing this facility permanently. More renewables on the grid make us even more energy secure without Aliso Canyon.

Engineer Bill Powers has critiqued the State reports, and concurs the numbers mean we do not need Aliso Canyon.

I urge you to look at the ulterior motives of many of those asking for the opening of Aliso, and/or if their information is factual.

I'm scared living in my home, why I am still sick, why my dog is still sick, and after a year what is considered long term? We desperately need health studies done. We need to be heard that we are still getting sick, and determine what is causing it. Please consider the leaking ground shown in photos by the AQMD, how will that stop if injection is allowed?

There is nothing reliable about the Aliso Canyon Facility. Any risk of re injecting is so huge compared to the risk of maintaining energy without it. Please shut it down permanently, and continue to work on safe, clean alternatives. Reliance cannot be safe at this facility, and the company running the facility cannot be trusted, they have already proven that. Thank you for taking this comment into consideration.
