Pursuant to the Committee's May 26, 2016 Scheduling Order (TN #211661) AltaGas Pomona Energy Inc. ("Applicant" or "AltaGas Pomona") submits this Status Report related to the pending application for Small Power Plant Exemption ("SPPE") for the Pomona Repower Project. Applicant continues to develop specific engineering and design elements of the battery storage project at the Pomona site. As noted in Applicant's August 16, 2016 Update to Status Report #3 (TN# 212801) and further explained in Applicant's August 18, 2016 Record of Conversation with CEC Staff Regarding SPPE (TN# 212839), depending on the final design for the battery storage project, the project description for the pending Pomona Repower SPPE application may be impacted.

Once the battery storage plans are finalized and all local approvals have been obtained, Applicant will provide CEC Staff with additional details as to whether changes will be required to the SPPE project description and the nature of any such changes, as well as any additional technical information that may be relevant to CEC Staff's review of the pending Pomona Repower SPPE application.

To reiterate our August 17, 2016 discussion with CEC Staff, the battery storage project is separate and distinct from the Pomona Repower Project and has no effect on the CEC's jurisdiction over the pending SPPE application.
