**ALAMITOS ENERGY CENTER  
STATUS REPORT #22**

Pursuant to the *Committee Scheduling Order* issued on January 14, 2016,<sup>1</sup> AES Alamitos, LLC (the “Applicant”) files this Status Report #22 to inform the Committee on the progress of the Alamitos Energy Center (“Project”) Application for Certification (“AFC”) proceeding.

The Applicant supports the schedule set forth in the *Revised Committee Scheduling Order* issued on August 31, 2016.<sup>2</sup> As the Applicant has previously stated, a timely decision is essential for the project to meet critical construction and operation-related milestones.

The Applicant has reviewed the Staff’s *Motion for Summary Adjudication*<sup>3</sup> and will file its response on or before September 19<sup>th</sup> as directed by the Committee.<sup>4</sup> The Applicant supports Staff’s Motion and requests that the Committee issue an order finding that: (1) the AEC project, for the purposes of the Commission’s environmental review pursuant to its certified regulatory program under the California Environmental Quality Act (“CEQA”), does not require the decommissioning or demolition of Alamitos Generating Station Units 1-6 to construct AEC; (2) because decommissioning or demolition of the Alamitos Generating Station Units 1-6 are not part of the project under review by the Commission, the direct and indirect effects or impacts, as defined in CEQA, need not be considered in the Final Staff Assessment or Presiding Member’s

Proposed Decision; and (3) decommissioning or demolition of the Alamos Generating Station Units 1-6 will not be a topic of consideration at the evidentiary hearings as such topics are not relevant to any decision that the Commission must make in this proceeding.
